Dear Friends and Colleagues:

It is still February as I am writing, and I am reminded yet again of what a busy time of year this is for both admissions offices and high school counseling offices, right on through the spring. During this time of year, it can be difficult to keep up our enthusiasm and feed our own personal and professional development, when there is so much to do. Both high school and admissions counselors are experiencing that "in-between" time with high school seniors and juniors. The seniors are hearing from the colleges to which they have applied, and the juniors are just beginning to think about the college search process in earnest. High school counselors are meeting with both groups to allay fears and plan strategies. Colleges are corresponding with seniors in anxious anticipation of May 1, and with juniors in what will be at least a yearlong relationship. Plans are being made on both sides of the desk for events and activities centered around advising and informing. Given the weather in New York State, February has often seemed the longest month of the year (despite what the calendar says), and Spring a long way off. For me, all this activity has traditionally provided a welcome distraction, making February go just a little faster and Spring seem to come just a little bit sooner. I hope that is the case for you. However, it is also a time of year when there are many opportunities for professional development. I hope that you will have time to participate in some of them, despite all

the demands on your time.

Two important activities offered by NYSACAC at this time of year are the New York State Legislative Forum and the Regional Forums. The New York State Legislative Forum was held February 2-3 in Albany, and was a great success again this year. Chaired by Joanna Broda, NYSACAC/Pace University, and Brian Petraitis, College Board, the Legislative Forum is made possible by a consortium among nine organizations, including NYSACAC and the College Board. The Forum focused on making education funding a priority in 2004, and included 95 appointments NYS legislators. with Participants advocated for restored funding for education; protected affirmative action initiatives; counseling legislation; and the rights of undocumented students. An exciting feature of this year's program was the participation of 20 high school and college students, in addition to the high school and college admissions counselors who attended. We hope to expand the participation of students in next year's Forum. The success of the Legislative Forum over the past six years demonstrates how important it is for every member of our Association to contact their State representatives and let them know that the proposed cuts to education in the Governor's budget are unacceptable.

Regional Forums/Professional The Development Forums are a continuing source of pride for NYSACAC and the colleges/universities which host them. Maryelizabeth Amico and Patty Peek have worked with colleagues from across the state to prepare for this vear's Professional Development Forums. They will be held at seven sites in March and one site in April. The topic this year is "Back to Basics: Revitalize and Rejuvenate." Everyone was sent a postcard with the list of dates, places, and contact information. There is no fee for the Professional Development Forums, so if you haven't already reserved your seat at the one nearest you, check our website for dates, locations, and registration information

Plans for other upcoming events are also proceeding apace. Kelly Herrington is spearheading the plans for Camp College 2004. He and his steering committee are making plans for two Camp Colleges this year, to be held at Niagara University and Manhattan College in Summer 2004.

Stay tuned for further details. Carl Forbes, Jo Anne Phang, and the Human Relations Committee are making plans for the highly successful Coming Together Conference, which will precede the Annual Conference in June. Which brings me to Lisa Sohmer, Dennis DePerro, and the Conference Steering Committee, who are working tirelessly on the 26th Annual Conference, which promises to be another exceptional professional development opportunity. This year's Conference, being held June 2-4 at Le Moyne College in Syracuse, will over 50 interesting include and innovative workshops. The Legislative Session will once again precede the **Opening Session; NACAC President-Elect** Frank Sachs will be the Keynote Speaker; and Friday morning's closing workshop will address early intervention programs. As always, there will be lots of good conversation and good entertainment at this year's Conference. I hope you will mark your calendar to join us in June.

So, while it is a busy time for us all, I hope that you will be able to take a few moments to stoke your own personal and professional fires. Many thanks for all that you do. Take care of yourselves.

The Legislative Forum: A First-Timers Impression

As a new member on the Executive Board, I went to the Legislative Forum because I felt I should. I have to admit, I wasn't overly excited to go. It's not that I'm not interested, it's just that I am rather apathetic about most things political. And, while I firmly believe that educators and educational institutions never receive all of the funding that they deserve, I also understand that the buck needs to stop somewhere. Unfortunately, there are more good causes than there are tax dollars.

As a newcomer, I wasn't sure what to expect. Me, a lobbyist? Kudos to Brian Petraitis and Joanna Broda for their excellent training. In a very short time, we learned *how* to lobby, *why* we should lobby, and *what* issues are important. The information sheets distributed to us clearly and concisely laid out the issues and the statistics we needed to focus on. The appointments had been made and all we, as new lobbyists, needed to do was show up and demonstrate how much we care.

In the elevator on our way to our first appointments, Lisa Sohmer and Joan Zimmer pointed out to me that no one in public office will tell you that they do not support education. Our job, then, was to help the legislators and their aides understand—in a direct and personal way-how these funds benefit individuals. As lobbyists, we needed to humanize the process; to explain that without HEOP funding, some students simply won't be able to attend college; and by reducing TAP, other students will be required to take on more loans, severely limiting their options when it comes to higher education.

Seriously—they listened! In general, the Representatives, Senators, and their aides know what the issues are, but they may not know how cuts in grants and other education funds affect their constituents. One of the aides I spoke with had no idea that HEOP and EOP students are more likely to stay in NYS after their college graduation than are other students. My interest in class issues (I was a sociology major in college) also came into play as I explained why first generation college students were more likely to come from families who are reluctant to take out loans, and from backgrounds where credit cards and debt were NOT an acceptable way to live from day to day. Thus, if going away to college (or even staying home and attending college) meant taking out loans, it might mean not attending at all.

I am pleased to report that my experiences at the Legislative Forum were truly positive. It was well worth my while to go. I encourage all NYSACAC members with an interest in these very critical issues to consider attending the Forum next year. (This is especially true of traditionally underrepresented geographic areas, i.e., school districts in more rural areas). As a result of this experience, I have come to realize the important role that we, as educators, and as voters, play in the political process.
